This document may not be shared, published, circulated, reproduced or distributed in whole or part to any other person without the prior written consent of the executive committee.


Revision and Updates


Introduction

The APAS executive committee can invite new members (Ayurvedic centers or Individual) or members of the public can email APAS to join in as a member.


Scenario A: If APAS Knows there is a New Ayurvedic Centre or Wants to invite a member of the punlic

ROLES AND RESPONSIBILITIES OF THE DISCIPLINARY & GRIEVANCE COMMITTEE

The primary role of this committee is to

- 1. Convene if there is a case of grievance towards a member of APAS or their center's services.
- 2. Conduct a thorough investigation regarding the complaint.
- 3. Advice a resolution plan to ensure the respondant's complaint is addressed.
